



## **Public exhibition of Sydney Harbour National Park plan of management draft amendment: sustainable visitor use (Clark Island, Shark Island, Rodd Island and Fort Denison)**

The National Parks and Wildlife Service (NPWS) is currently exhibiting the Sydney Harbour National Park Plan of Management draft amendment: sustainable visitor use (Clark Island, Shark Island, Rodd Island and Fort Denison).

The park is in the Greater Sydney region of New South Wales and includes the islands and part of the foreshore and headlands of Sydney Harbour managed by NPWS.

The amendment is being made to allow NPWS to deliver on the key goal of the 2012 [plan of management](#) to increase opportunities for the public to enjoy the park and enrich the visitor experience through the revitalisation of the Sydney Harbour Islands. The amendment will also ensure that the plan better reflects the way that NPWS manages and assesses sustainability of visitor use in the park.

The draft amendment proposes changes to:

- Management arrangements for events and visitor numbers on Clark Island, Shark Island, Rodd Island and Fort Denison,
- Leasing arrangements for Fort Denison, and
- Options for construction of facilities to support sustainable visitor use and park operations on Fort Denison.

The draft amendment should be read in conjunction with the Sydney Harbour National Park Plan of Management.
